

CHARLOTTE B. COLLETT MEMORIAL SCHOLARSHIP PROGRAM

PURPOSE:

To reward a student who has demonstrated a commitment to community service in the Town of Manchester.

To recognize a student who has demonstrated and maintained academic excellence at the high school level.

To provide needed financial support for the student who is pursuing a higher education.

GENERAL POLICY:

The dollar amount of the Charlotte Collett Memorial Scholarship award will be determined by the Manchester Town Council each year and will be awarded as a "one-time" award.

The amount of the award for this fiscal year is up to \$1000.00 and will be awarded at the discretion of the scholarship committee in June 2010.

The scholarship will be awarded to the most qualified applicant(s) for that year. The scholarship can be awarded to up to two (2) students.

STUDENT ELIGIBILITY:

Applicant must have demonstrated a commitment to the Town of Manchester by extensive community service. Applicants who reside within the municipal boundaries of the Town of Manchester will get special consideration.

Applicant must have acceptance into a college or university.

Applicant must have good scholastic standing.

Applicant must be a graduating high school student.

SELECTION CRITERIA:

A commitment to the community.

Letters of recommendation from community organizations at which applicant has volunteered.

Completion of the attached scholarship application.

Academic achievement during grades 9 through 12.

SELECTION PROCESS:

The Manchester Town Council shall select a scholarship selection committee that shall include the Mayor and two (2) Council members.

The scholarship information will be forwarded to the local high schools and be available at the Manchester Town Office by no later than November 30th.

All applications must be received by the Town Office by May 1st.

The selection committee will determine the most qualified applicant by June 1st and inform the Council of their selection at the June Council Meeting.

PAY OUT PROCEDURES:

The scholarship award shall be issued to the institution that the student will be attending.

Although the check will be made out and sent directly to the institution, a Scholarship Certificate will be presented to the winners at the June Council meeting.

If the student selects another institution at a later date, the check will be voided and another issued to the appropriate institution.
